## REGISTRATION & VOTING

Voter registration forms are available at: libraries, schools, social service agencies, Motor Vehicle Administration offices, and the Board of Elections.

Requests for changing party affiliation must be made at least 92 days before a primary election. Registration books close 21 days before each election for new registrations and for changes of name/address.

If you are a registered voter, you will receive a specimen ballot indicating your polling place from the Board of Elections shortly before each election.
